Week 70 The Fight for Life

Dear City Intercessor,

This week's prayer is perhaps one of the most important we have engaged in together.

On Wednesday, Dec. 1, the Supreme Court will hear Dobbs vs Jackson which is perhaps the strongest chance since 1992 to overturn the horrendous Roe v Wade decision legalizing abortion. It is estimated that over 62.5 MILLION babies have been murdered since abortion became legal in 1973. Lord forgive us.

Although the Dobbs vs Jackson case is not expected to completely overturn abortion, it IS expected to begin that process and create severe limitations removing late-term abortions.

Although you would never know it by our own media, America is one of the few countries (1 of just seven) which allows abortions past 20 weeks.

Pro-life undercover investigator Sandra Merritt, who helped expose Planned Parenthood by revealing actual footage of their negotiations to sell baby parts, was required to pay \$13 million for legal fees and damages to Planned Parenthood last year by U.S. District Court Judge William Orrick III who refused to allow the jury to see the actual footage! He also awarded Planned Parenthood **six times** the amount of the original jury verdict in attorney fees and costs.

He is the same judge who ordered David Daleiden, another undercover investigator, to pay Planned Parenthood \$870,000 in punitive damages and found him guilty of supposed "multiple crimes" in a ruling that according to Liberty Counsel, "no other citizen journalist or journalism organization has ever been charged with a crime for undercover recordings made in the public interest."

This is evil against our most innocent ones along with the corruption and injustice that has been perpetrated against those who have courageously worked to expose and undo this evil! The case that goes to the Supreme Court this week can help undo this corruption and evil.

(I ask you to pray not only this week, but please keep this as an ongoing area of prayer until a ruling is made probably sometime Spring 2022.)

Father, we repent for the millions of babies who have been murdered where they should have been safe—in their mother's womb. Forgive us for allowing this travesty of a law which has legalized murder. The blood of the slain cry out to you for justice. We cry out to you for justice.

We pray as Dobbs vs Jackson goes before the Supreme Court this week. After it is presented, may it will never leave the minds of these men and women until a decision has been reached. This time, Lord, may it be a just decision that protects the life of the unborn. We pray that the evil law from Roe v Wade will be overturned. But Lord, it's not enough to see it overturned. We need to see hearts changed who have supported this evil, so that it will not return. Hearts that are changed to recognize it as evil.

Father, You also see those who have profited from this blood-shed. Those who have lied to the public to try to make us believe that abortion laws are necessary to protect the mother and is only used when the mother's life is in danger. You see how they have taken babies born alive and mutilated them for their parts and then denied their actions. Lord, you also see how courageous individuals who have worked hard to expose these evil deeds, have been targeted for destruction, bullied and put in prison, required to pay enormous fines or legal fees back to these murderous organizations. We ask that you would step in as the righteous Judge and vindicate the righteous! Restore that which has been stolen! You said that evil will slay the wicked, and those who hate the righteous will be condemned. That is Your Word Lord—so may it be.

We pray also regarding those who are called "Justices" who know nothing of justice. They have justified the wicked and condemned the righteous.
